Fee Refund Rules

Fees will be refunded according to rules book of D.T.E. (Deptt. Of Technical Education and Skill Development, Government of M.P.) only

Hostel fee refund rules:-

- (a) Minimum deduction upto 30 days, one month room rent and registration charge will be deducted.
- (b) After 30 days two months room rent and registration charge will be deducted.
- (c) After 60 days 6 month room rent & registration charge will be deducted.
- (d) After one semester, no fee will be refunded.
